## SAFETY POLICY OF THE NATIONAL BUSINESS AVIATION ASSOCIATION

November 3, 2018

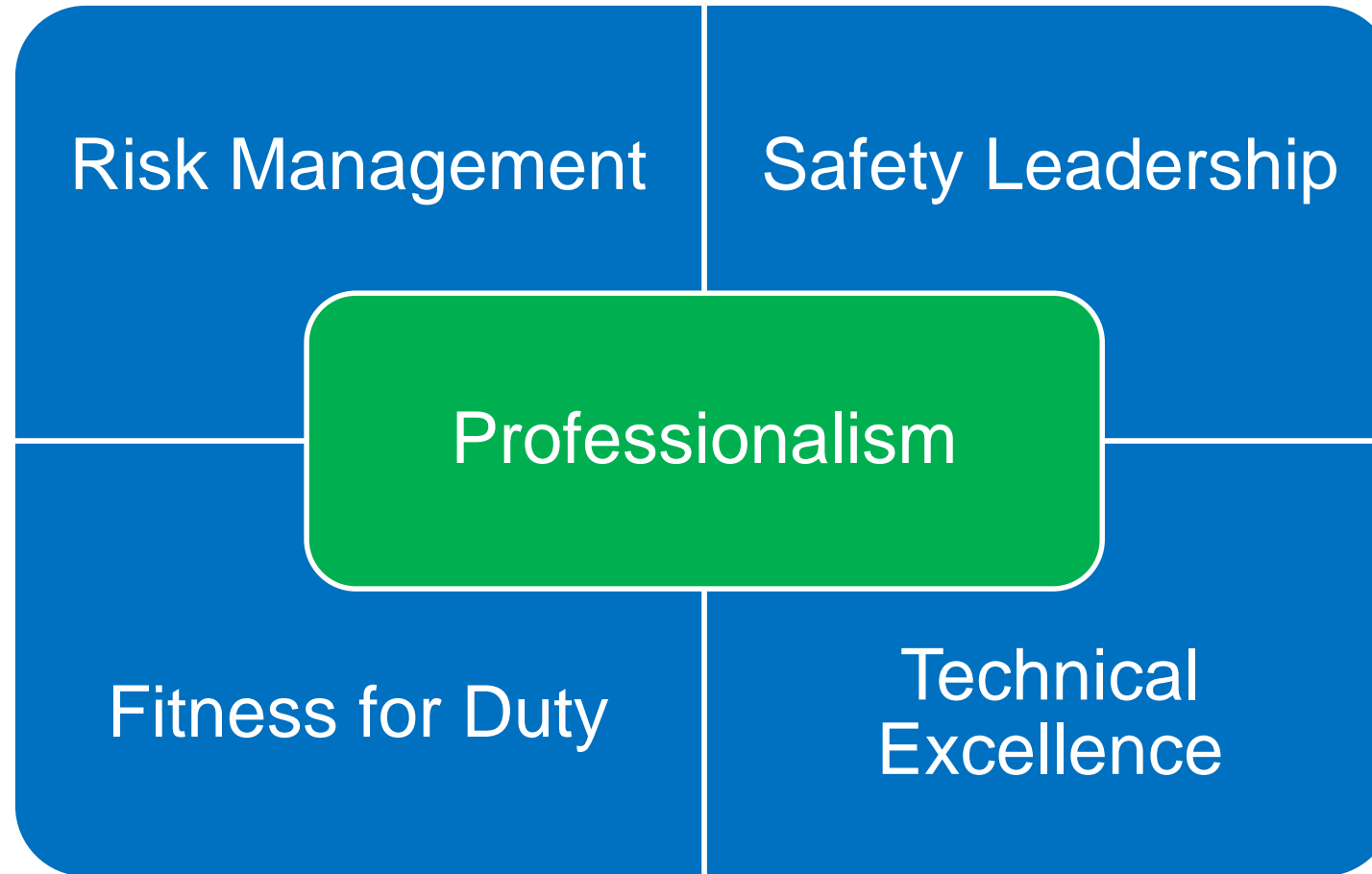
